Overnight Trips

There are two trips that were presented to the Board for consideration – the NAVY SeaPerch trip June 1-3, 2018 at the University of Massachusetts Dartmouth and the (MDOT) TRAC Michigan Bridge Competition April $30-May\ 1$, 2018 at the Amway Grand Plaza, Grand Rapids.

Six teams will be participation in the TRAC Michigan Bridge Challenge. This is a FREE event, as the Michigan Department of Transportation covers all costs for students.

Three teams qualified for the International SeaPerch Challenge in June. Funding for this will come from both students and donations/sponsorships.

Steve Clegg moved that the Board approve both overnight trips -2018 International SeaPerch Challenge at the University of Massachusetts Dartmouth on June 1-3, 2018 and the TRAC Michigan Bridge Challenge at the Amway Grand Plaza (Grand Rapids, MI) April 30- May 1, 2018 as described. Summer Facilities Work

Three summer projects were presented – high school gymnasium bleachers, elementary school roofing, and the sidewalk on Kehoe Street.

Gymnasium Bleachers - The first job was the high school gymnasium bleachers. There were two bids received – Interkal for \$105,772.71 and Irwin Seating for \$140,434.51.

Kevin Ward moved that the Board accept the bid submitted by Interkal LLC for the replacement of the high school gymnasium bleachers for \$105,772.71. Supported by Steve Clegg. All aye; motion carried.

Elementary Roofing – This project only received one bid – Superior Services for a total of \$41,550, including optional 5-Year warranties.

Shirley Harris moved that the Board accept the bid submitted by Superior Services RSH, INC at a total (plus warranty cost) of \$41,550. Supported by Steve Clegg. All aye; motion carried.

Kehoe Sidewalk - The sidewalk down Kehoe received three bids – First Choice Builders \$32,841; Rathburn Contracting \$28,925; and Rock Hard \$25,330.

Chad Erickson moved that the Board accept the bid from Rock Hard in the amount of \$25,330. Supported by Steve Clegg. All aye; motion carried.

Administrative Searches

The elementary principal and special education/student services director closes April 20.

Policy Review/Approval

All 2000-level policies were presented for approval; one change was recommended to policy #2521, simply striking the word "shop" from a sentence (referring to the previous shop class).

Dale Wingerd moved that the 2000-level policies be approved as presented. Supported by Shirley Harris. All aye; motion carried.
