TRAC Michigan Bridge Challenge - Six teams participated in the Grand Rapids competition. The biggest challenge was using balsa wood, not spaghetti as they have in the other competition in previous years. There were 950 applications, with only 520 submitting proposals. Of the proposals, only 198 teams were invited to participate, with 6 of those teams coming from Clinton!
