Student Growth

Strategic Goal Statement: Students at all levels/buildings will have opportunities to be challenged, as well as choice in curriculum.

Objectives

- Develop and implement a plan that offers more paths for student needs at all levels/buildings.
- Develop and implement a plan that promotes and educates all stakeholders about the purpose of, and differences between, AP classes and dual enrollment.

Strategic Goal Statement: Ensure all learners are on track to meet grade level readiness at K-8, as well as college and/or career readiness standards from 9-12.

Objectives

- · Develop and implement a plan to identify and advance areas of weakness in regard to grade level and college/career readiness.
- Develop and implement a plan that reviews and improves grade level standards/readiness for promotion.
- Develop and implement a plan to review and create system changes to the reading curriculum for all grade levels.

Strategic Goal Statement: Teachers will meet the needs of each individual student to help them achieve their potential.

Objectives

Develop and implement a plan that allocates resources at the elementary level to differentiate instruction K-5, specifically in the area of reading.

• Develop a plan to improve growth of the bottom 30% of students in the elementary to remove the elementary from being a focus school.

Marketing

Strategic Goal Statement: Clinton Community Schools will enhance its image to increase enrollment and encourage positive school and community partnerships.

Objectives

- Develop and implement a program of promoting the accomplishments of its teachers, staff, students and graduates.
- · Develop and implement a plan to provide extended learning opportunities for the community.

Community Relations/Communication Goal

Strategic Goal Statement: To strengthen internal and external communication practices to improve public perception, employee satisfaction and promote community partnerships and participation.

Objectives

- Develop and implement a plan of communication that provides transparency to the community and encourages community investment in the district.
- Develop and implement channels of communication between buildings in order to provide a cohesive learning environment.

Professional Development

Strategic Goal Statement: To develop a system of effective and engaging professional development that will contribute to the learning and growth of all district employees.

Objectives

- Develop and implement a plan for on-going and relevant professional development using continuous application, reflection, and evaluation.
- · Develop and implement a plan that is encouraged and supported by the district.
- Develop and implement professional development that will focus on 21st century and progressive learning techniques that align with current researched-based practices.

Facilities

Strategic Goal Statement: Promote a positive and safe school environment through the maintenance of school facilities and grounds.

- · Develop and implement a plan for replacing, hiring and responsibilities for a facilities supervisor
- Develop and implement a plan to ensure safe and efficient transportation.
- Develop and implement a systematic process for preventative measures within district property and equipment.
