#### **`IV.** Clinton High School Face Shield Production

On April 29, more than a month into the pandemic shutdown of in-person classes, Clinton High School joined with an organization to help produce Face Shield PPE for small essential organizations and health facilities throughout the state of Michigan. Bennet Zbikowski volunteered his time and talent with 3D printers to print the frames which were then assembled to produce the finished face shields. Bennet was a graduating Senior who was also preparing for AP Exams, graduation, and looking ahead to college. In the midst of this, he volunteered to house the printers at his home so that he could maximize the number of frames that could be printed. This week he will be concluding after 14 weeks of managing the printers and keeping them functional when replacement parts were needed. He did this with no fanfare, compensation, or even the ability to put it on a scholarship application. His selflessness has contributed to manufacturing almost a thousand face shields by Clinton Community Schools with support from the community. He is to be commended!

Quick background and facts on the Face Shield Program as of August 4th: This is the 5th month in manufacturing faceshields which was initiated by the Bay Mills Indian Community and Bay Mills Community College. Some summary state-wide statements:

- 10,122 shields delivered to 252 organizations/recipients-free donation
- 3 locations of manufacturing (southeastern, lower northern and Eastern Upper regions)
- 5 organizations (BMCC, Clinton Community Schools, Inland Lakes, EUPISD STEM, Square One)
- Phase I completed (hospitals/health centers, business reopenings)
- Phase II in progress (back to school K-12 supply)- ISD distribution

• Shields are no charge with costs incurred by BMCC/organizations and volunteers

Regionally, we have assembled and distributed over 1400 free face shields in SE Michigan, including :

- 100 to long-term facilities in Adrian
- 200 to the Dominican Sisters in Adrian
- 20 to the Village of Clinton
- 8 to the Clinton Township Library
- 271 to Clinton Community Schools for Transportation, Maintenance, Football Staff, and faculty and staff.

This has been accomplished at no cost to the district thanks to local donations and financial support from the Bay Mills community. Thanks go to the Clinton Administration for supporting the effort, Adam Covell for technical help in setting up printers, Carol Wahl for helping with ordering materials, and in our community Steve Clegg and the Clinton Rotary, as well as Cyndi and Dennis Milligan. They have been crucial in helping prepare parts and assemble the face shields, as well as making deliveries to supply the shields to SE Michigan.
