XII. General Fund Budget 1st Revision

Attached is the first budget revision for the 2020-2021 school year. Increased revenue of \$1,750,865 due to increased enrollment and foundation allowance from state aid funding along with federal Coronavirus funds. Expenditures also increased \$728,877 due to Coronavirus, Virtual Platforms and previous budget cuts.

Due to these changes, expenditures will exceed revenue by \$73,294.

XVI. Purchase of Chromebooks

These are to replace devices we had purchased last January/February that were meant to replace 7th/8th grade Chromebooks. These devices arrived in March; we didn't get to distribute them before we shut down. We ended up using some of these devices for the incoming third graders this fall which allowed us to avoid the shortage that many schools are still experiencing. These devices will be used to replace current 9th grade devices. The RFP was for 140 Chromebooks. We received a total of 6 bids. The top 3 bids are listed below.

Firefly Computers \$41,403.60 Archangel Tablets \$46,123.00 **Trinity3 Technology** \$41,860.00

My recommendation is to go with Trinity3 Technologies bid at \$41,860. \$33,460 will come from Sinking Fund, \$8,400 will come from the Device Insurance Fund. They are the second lowest bidder behind FireFly, by \$456.40. Trinity3 is offering a better device and we currently have a good working relationship with them which I feel is worth the few extra hundred dollars.
